Drivers Against Driver Inc.

The target of CRA and Labour Canada Driver Inc. enforcement needs to be twofold -- companies and drivers. While company enforcement has been a challenge so too has drivers. Please ensure that all completed petitions that are sent to CTA include the cover page of the petition, along with the pages that have signatures and addresses. To be a legal petition the document must contain atleast 25 signatures.
